3. REPORTS.

- 3.1 TREASURER: The bank balance remains at \$2805, with no outstanding accounts.
- 3.2 MEASURER: Not represented.
- 3.3 HANDICAPPER: The handicaps for the SPYC Opening Day will require calculating as all fleets will be sailing the same course.

3.4 SAILING COMMITTEE: G. Murray expressed concern that the meeting minutes are not always forwarded to the committee members.

There was mention of a changed starting sequence for the two windward/leeward races on 3 Nov and 4 Feb. This requires clarification.

From past experience, the SS27s required better separation from other fleets when sailing in this event.

The SPYC Billy Run is an invitation race and so is open to yachts from other clubs. It will be run from Fremantle to The Cruising Yacht Club on 16 Feb.

All SS27s are to be advised and invited to participate.

3.5 SCRIBE. G. Aberle is O/S and will update the website after his return.

4. GENERAL BUSINESS.

4.1 RACING FIXTURE. This is now complete and checked against the Red Book. It is ready for distribution.

As mentioned above, the Billy Run is an invitation race.

4.2 ANNUAL PRESENTATION DINNER. The Chairman has been in contact with RFBYC and SPYC for a dinner reservation on either Thu, 2 or 9 May 19.

- 4.6 MAN OVERBOARD. On his return, G. Aberle will summarise the submissions sent from the members and forward this information as a guideline to all skippers.
